



Competition terms and conditions

1. Introduction

- GPEX Central is organising the Best Teaching Practice Awards (the Competition) to discover what is the best teaching practice in the ELT industry within a community.
- The Competition runs in three stages:
 - Preliminary Stage: 12:00 on 08th June 2021 to 23:59 on 22 June 2021
 Registration closing date : 11th June 2021
 Video submission closing date : 22nd June 2021
 - Shortlisting Stage: 00:00 on 23 June 2021 to 23:59 GMT on 06 July 2021.
 - Competition Stage: opens at 00:00 on 07 July 2021 and closes at 23:59 GMT+8 on 21 July 2021.
 - Competition final will be on the 16th August from 16:00 to 17:00 (All times stated are GMT+8 Kuala Lumpur).
- Entries received after the end of Preliminary Stage will not be included in the competition. However, the data may still be used as per these Terms and Conditions.
- The Competition is free to enter for eligible teachers (refer to point 2).
- This competition is run by GPEX Central, a Cambridge Assessment English Authorised Platinum Exam Centre, and supported by Cambridge Assessment English and Cambridge University Press.


2. Teacher eligibility

To be eligible for the competition, a teacher must:

- Be a Cambridge CELT-P or CELT-S graduate, having completed the course.
- Be using Cambridge University Press teaching materials; or working under an institution that uses Cambridge University Press teaching materials.
- Be preparing learners in taking the Cambridge English Qualifications; or working under an institution that prepares learners for the Cambridge English Qualifications
 - Not be prohibited in participating in the Competition or receiving the prize under any applicable law.









3. How to enter the Competition (Preliminary Stage)


- Teacher must meet all the entry requirements.
- Teacher must then fill up the registration form on the Competition website : www.gpexcentral.org/BTPawards
- Following registration, teacher must record and submit a video, according to the Competition instructions, onto our webpage.
- By submitting the video on the Competition website, the participating teacher agrees that GPEX or Cambridge may publish video on the Competition website.

4. Shortlisting and Competition Stage

- At the end of the Preliminary Stage, nominations will be scored by a panel of judges who will select the top 10 ("Top 10") for both CELT-P and CELT-S, based on the following criteria:
 - Meet the video requirement (videos no longer than 10 mins, HD 1080p)
 - o Innovative lesson ideas and practices (Best Teaching Practice)
- After the Top 10 has been selected, they will be notified via email in the week commencing 07 July 2021 and will then need to record a teaching video, highlighting the Best Teaching Practice shared in the prior video.
- Submission of the final video must be done before 21 July 2021.
- The Top 10 will also go to a public vote on the GPEX Social Media Channel to decide on the most liked teacher.
- A judging panel composed of experts from Cambridge English Teaching, Cambridge Assessment English and Cambridge University Press will assess the Top 10 against the same criteria and will decide on Top 3 and the Winner of the Best Teaching Practice Awards.
- Results will be shared live on the 16th August 2021.









5. Opting out


- Teachers who registered in the Competition will be contacted and given an opportunity to opt-out at every stage of the Competition.
- Teachers will not be announced on the Top 10 without their consent.

6. Prizes and publicity

- All eligible teachers participating in the Competition will each receive a certificate of participation.
- The 4th to 10th placing will each receive the following prizes:
 - Cash prize RM 100
- 1st and 2nd Runner Ups will each receive the same prizes as teachers on the Top 10, with a different amount of cash prize:
 - 2nd runner up: Cash prize RM 300
 1st runner up: Cash prize RM 700
- **The Winner** will receive the same prizes as the runner ups, with a different amount of cash prize, plus the following:
 - o Cash prize RM 1,000
 - Free Cambridge Train the Trainer course
 - An invitation to join GPEX Virtual Conference 2021 as one of the guest speaker.









8. Other Terms and Conditions

- GPEX will make reasonable efforts to contact the Top 10, Runner Ups and the Winner. If they cannot be contacted within 7 days or indicate that they are not willing or able to accept the prizes and the associated publicity, GPEX reserves the right to offer the prize another teacher from the Shortlist.
- The prizes are non-transferrable and cannot be exchanged by the winner for cash or credit or any other product.
