## **Media Consent Form**

- 1. I hereby unconditionally grant to Cambridge, its departments, affiliates and licensees an exclusive, perpetual, worldwide, royalty-free, sub-licensable consent and licence to use, reproduce and publish any and all of the Image Rights in any medium/media in connection with the Purposes together with the right for Cambridge to authorise others to do so.
